A BILL

An Act to apply a sum out of the Consolidated Fund for additional expenditure for the service of the year 1958, and to appropriate such a sum for certain purposes.

WHEREAS the sum of seven hundred and thirty-seven million four hundred and sixty-seven thousand nine hundred and eighty-seven dollars (\$737,467,987) has been provided by the Supply (1958) Ordinance, 1957, the Supple- 82 of 1957. mentary Supply (1958) Ordinance, 1958, the Supplementary 4 of 1958. Supply (1958) (No. 2) Ordinance, 1958, the Supplementary ²⁶ of 1958. Supply (1958) (No. 3) Ordinance, 1958, the Supplementary 34 of 1958. Supply (1958) (No. 4) Ordinance, 1958, the Supplementary 59 of 1958. Supply (1958) (No. 5) Ordinance, 1958, the Supplementary 66 of 1958. Supply (1958) (No. 6) Ordinance, 1958, and the Supplementary Supply (1958) Ordinance, 1959, for the service of the year 1958;

AND WHEREAS it is now requisite to make a further provision of four hundred and eleven thousand seven hundred and fifteen dollars (\$411,715):

BE IT ENACTED by the Duli Yang Maha Mulia Seri Paduka Baginda Yang di-Pertuan Agong with the advice and consent of the Dewan Negara and Dewan Ra'ayat in Parliament assembled, and by the authority of the same as follows:

- 1. This Act may be cited as the Supplementary Supply short title. (1958) (No. 8) Act, 1960.
- 2. (1) The issue of a sum not exceeding four hundred Further and eleven thousand seven hundred and fifteen dollars for the year (\$411,715) out of the Consolidated Fund for expenditure 1958. on the various services specified in the Schedule for the service of the year 1958, not provided or not fully provided for by the said Supply (1958) Ordinance, 1957, the Supplementary Supply (1958) Ordinance, 1958, the Supplementary Supply (1958) (No. 2) Ordinance, 1958, the Supplementary Supply (1958) (No. 3) Ordinance, 1958, the Supplementary Supply (1958) (No. 4) Ordinance, 1958, the Supplementary Supply (1958) (No. 5) Ordinance, 1958, the Supplementary Supply (1958) (No. 6) Ordinance, 1958, and the Supplementary Supply (1958) Ordinance, 1959, is hereby authorised.
