



The Committee considered that it would not be proper to accept the nomination of the Honourable Enche' Tan Phock Kin as he was admonished by the House on the 29th April, 1961, for having committed a breach of privilege under Standing Order 85, while a member of the Public Accounts Committee (Second Session).

The Committee, however, agreed that the Honourable Enche' K. Karam Singh should be given, up to Tuesday, 7th June, 1961, the opportunity to suggest another person as the Socialist Front's nominee on the Public Accounts Committee, and that if he should fail to do so, then the total membership of that Committee should be allowed to remain at five members.
